INSTRUCTIONS

General Instructions

- 1. The notice of Postal Ballot is dispatched/e-mailed to the Members whose names appear on the Register of Members as on Friday,21st August, 2015 and the voting rights of members shall be in proportion to their shares of the paid-up equity share capital of the Company as on the said date.
- 2. Members have option to vote either through e-voting i.e. electronic means or to convey assent/dissent in physical form. A Member can opt for only one mode of voting i.e. either through e-voting or by Postal Ballot. If a Member casts votes by both modes, then voting done through e-voting shall prevail and voting done through Postal Ballot shall be treated as invalid.
- 3. Corporate and institutional Members shall be entitled to vote through their authorised representative with proof of their authorization, as stated below.
- 4. The e-voting period commences on Tuesday, 25th August, 2015 (10.00 a.m. IST) and ends on Thursday, 24th September, 2015 (5.00 p.m. IST). During this period, Members of the Company, holding shares either in physical form or in dematerialized form, as on Friday, 21st August, 2015; may cast their vote electronically.
- 5. For detailed instructions on e-voting, please refer to Point No. '13' of the Postal Ballot form.
- 6. This Postal Ballot Form is provided for the benefit of Members who do not have access to e-voting facility.
- 7. The Scrutinizer will collate the votes downloaded from e-voting system and votes received through post to declare the final result for each of Resolutions forming part of the Postal Ballot Notice.

Instructions for voting physically on Assent/Dissent Form

- 1. A Member desiring to exercise vote by assent/dissent should complete this Postal Ballot Form (no other form or photocopy thereof is permitted) and submit the same in the enclosed pre-paid envelope addressed to the Scrutinizer, Mr. Prashant Diwan, Practising Company Secretary, Unit: Sonal Adhesives Limited, C/o System Support Services, 209, Shivai Industrial Estate, 89, Andheri Kurla Road, Sakinaka, Andheri (East), Mumbai 400 072, so as to reach by 5.00 p.m. on Thursday, 24th September, 2015. Unsigned, incomplete or incorrectly ticked forms are liable to be rejected and the decision of the scrutinizer on the validity of the forms will be final.
- 2. The Postal Ballot Form should be signed by the Member as per the specimen signature registered with System Support Services, Registrars and Transfer Agents of the Company ('RTA')/Depositories. In case of joint holding, the Form should be completed and signed by the first named Member and in his/her absence, by the next named holder. A Power of Attorney (POA) holder may vote for and on behalf of a Member, mentioning the registration number of the POA registered with RTA, or enclosing attested copy of the POA.
- 3. In respect of shares held by corporate and institutional Members (Companies, Trusts, Societies, etc.), the duly completed assent/dissent Postal Ballot Form should be accompanied by the certified copy of the relevant Board Resolution/appropriate authorization, with the specimen signature(s) of the authorized signatory(ies) duly attested.
- 4. Votes should be cast in case of each resolution, either in 'FOR' or 'AGAINST' by putting a tick ($\sqrt{}$) mark in the appropriate column in the Postal Ballot Form. The assent or dissent received in any other form shall not be considered valid.
- 5. Duly completed Postal Ballot Form should reach the Scrutinizer not later 5.00 p.m. on Thursday, 24th September, 2015. Postal Ballot Form received after 24th September, 2015 will be strictly treated as if the reply from the Members has not been received.
- 6. A Member may request for the duplicate Postal Ballot Form, if so required, to RTA at the address mentioned in serial no. 1 above. However, duly filled in and signed duplicate Postal Ballot Form should reach the Scrutinizer not later than date and time specified in serial no. 1 above.
- 7. A Postal Ballot Form will be rejected if it is received torn, defaced or mutilated to an extent which makes it difficult for the Scrutinizer to identify either the Member or as to whether the votes are in favour or against or if the signature cannot be verified.
- 8. The decision of the Scrutinizer on the validity of the assent/dissent of the Postal Ballot Form will be final and binding.
- 9. The results declared along with the Scrutinizer's Report shall be placed on the Company's website www.sonal.co.in and on the website of CDSL www.cdslindia.com within two days of the passing of the resolutions and communicated to BSE Limited, where the shares of the Company are listed.
